- The treasury update since the 2019 State Convention includes the following:
- Closed the Fiscal Year 2019, prepared the draft Financial Review Report and worked with the Financial Review Committee at the review on July 27 and addressed the review comments. The accounts were in good order!
- The Financial Review Committee had some recommendations for consideration that were brought to the Executive Committee. The final financial statements were shared with the full Board of Directors via email.
- Recorded the transactions of the organization and generated financial reports reconciled to the cash accounts and investment account for the September Executive Committee meeting.
- Created a new chart of accounts that better matches accepting accounting practices. The budget and 2018-2020 financial statements were renumbered for the Executive Committee to review.
- Created a new Expense Voucher form and it is available for all at gfwc-wi.org/formscalls.
- Renewed key software licenses.
- Arranged for a tax return review for the 2017 tax return and started preparing documents for the 2018 Form 990 EZ.
- Renewal of Class A and Class B raffle license.
- Sent the Treasurer's Memo for dues and excel roster files to 48 clubs (both presidents and treasurers in most instances) via email.
- Created a binder for and transitioned the Health Scholarship Chair position to a new Chair.

#### **Known Upcoming Work**

Compilation of member rosters as they arrive from clubs – All clubs have been instructed to update the file as it was sent to ensure the state database of members and emails can be readily updated. Many hours have been put into creating a clean email list to ensure all members are properly notified when a new WI Clubwoman is available.

- Collection of dues and communication with HQ
- Preparation and filing of Form 990Ez and WI Form 5
- Help develop an on-line system that does not require a PayPal account for meeting reservations
- Arrange for an insurance review to ensure GFWC-WI is properly protected given its current size

#### **Other Activities**

The Treasurer is an active participant in the following committees: Executive, Health Scholarship, Investment, Budget, Amendments and Policies, Communications & Public Relations and Wisconsin's Own Library.

All the Committees have had one or more conference calls or email exchanges since the State Convention. In addition, most committees have planned meeting dates between now and the Winter Workshop.

### **GFWC 7 GRAND INITIATIVES - HOW ARE WE DOING?**

It was about a year ago that 2018-2020 International President Mary Ellen Brock challenged every club in the whole organization with getting behind seven (7) Grand Initiatives. It's a two year challenge and there's still time to achieve and over achieve the goals!

#### Updates on how we're doing as an organization internationally and as a state:

**1** 1,000 Projects - MLK Jr. Day on January 21, 2019 and January 20, 2020

Last year (January 21, 2019) 790 projects were done; in *Wisconsin 15 projects completed*.

2) 1,000 Projects - Women in the Military

To date 799 projects completed; in Wisconsin there were 22 projects.

**3**] 1,000 Members donate \$1,000 to the Million Dollar Club



To date 99 members, have joined. This is a "stat" we do not collect in Wisconsin.

4) 2,500 Members join Legislative Action Center

Since July 1, 2018 1,594 members have joined. This is a statistic also not collected by Wisconsin however, Deb Brossard is aware that approximately 20 members joined; the Blanchardville club added 4 alone!





5) 20,000 Trees planted by Federation Day/Arbor Day April 24, 2020

To date 17,811 trees have been planted. *Report was due April 1, so sorry to report no trees planted in Wisconsin by April 1, 2019. We are confident it will be different by April 2020!* 

6) 40,000 Pairs of Shoes donated - Soles4Souls or Nike Reuse-a-Shoe

To date 36,763 pairs of shoes have been donated. *Wisconsin donated 373.5 pairs of shoes! (every ½ pair counts!)* 





**7)** 55,000 Dr. Seuss books donated to local children's programs

To date 50,716 Dr. Seuss books have been donated. Wisconsin donated 380 books.

#### **GFWC 3 NEW BRAND INITIATIVES - IT'S TIME TO ACT!**

This is our opportunity to pass important bills and reestablish GFWC as an organization that can get bills passed, like it did with the Pure Food and Drug Act. This is our opportunity to stand united, each and every one of us, for causes that matter to us. This is our opportunity to make a difference. **Seize this opportunity**.

#### **1)** 1,000 Calls or Emails by members to United States Legislators on <u>Monday, September</u> <u>23, 2019</u> in support of and urging passage of Miranda's Law.



The Miranda Vargas School Bus Driver Red Flag Act (Senate: 1787 and House 2793) will establish a bureau that will receive notification of any moving traffic violation incurred by a school bus driver and send such notification to the company that employs the driver, and also to the school district. This Bill will keep unsafe drivers off the road and away from children. Ten-year-old Miranda Vargas was killed when her school bus driver, later found to have a long history of license suspensions, made an illegal U-turn on a major highway, colliding with a dump truck.

#### **2)** 1,000 Calls or Emails by members to United States Legislators on <u>Wednesday, October</u> <u>23, 2010</u> in support of and urging passage of the 3D Gun Bill.

The 3D Printed Gun Safety Act of 2019 (Senate 1831 and House 3265) would amend Chapter 44 of title 18 US Code and prohibit the distribution of 3D printer plans that can be used to program 3D printers and create firearms that are untraceable and potentially undetectable. The ability to print plastic guns using a 3D printer increases the risk that people prohibited from possessing firearms under federal law will obtain a firearm through 3D printing.

**3)** 1,000 Projects will be planned by clubs and states to celebrate the 100th Anniversary of Women winning the Right to Vote on August 26, 2020.

# WELCOME TO THE MEMBER PORTAL

#### It's called: MemberSuite

#### What is MemberSuite?

- It's GFWC's new members-only portal. It's administered by GFWC through a self-contained Association Management Software (AMS).
- This means only GFWC will see or use any information that you enter.
- The system puts your membership experience in one place. This means you can immediately access documents, shop in Marketplace, keep track of your donations, and more, all in one interactive place.

#### As a member - How to get started:

- 1. Visit the GFWC Member Portal at gfwc.users.membersuite.com/home.
- 2. Click on the profile icon in the top right corner and select "Login."
- 3. Select "Forgot your password?"
- 4. Enter your email that receives News & Notes each week.
- 5. You'll receive a code in your email that you can enter to create a password.
- 6. Update your own member profile.

#### Tips for club president:


As a club president, there's already a MemberSuite account associated with your email address.

As Administrator you are the primary contact for your club, which puts you in charge of ensuring that your club information is accurate on MemberSuite. Add your club roster. Make easy and efficient changes to your roster in one convenient location.

If the president listed for your club profile isn't correct, you should call GFWC at 202-347-3168 or email gfwc@gfwc.org.

When you log in to your MemberSuite account, it will give you the option to choose between a personal profile or your club's profile.

You can maintain both profiles with just one login. You can even go back and forth by clicking the profile icon in the top right corner to "Switch Profile" at any point.



It's GFWC-WI's leaderships' understanding that in the future State Federations will be able to use MemberSuite to manage dues payments. At this time we realize this is a new rollout and we can expect to learn more about its advantages e.g. helping clubs stay organized, transitioning leadership, fostering member connection to the larger GFWC community and all around improving the GFWC membership experience!





#### Membership: Mentoring New Members Submitted by: Abby Lorenz, Membership Chairman



Do you remember how you felt when you first joined a new organization? It can feel lonely until you find someone who welcomes you with a smile and introduces themselves. When a new member joins your club, I recommend appointing a mentor, or seasoned club member, to either call or personally meet with the new member outside of club meetings to discuss the many aspects of GFWC and your club. For example, you could talk about club

dues, expectations, procedures, programs, history, projects and answer any questions the new member may have. It is important to welcome your new member with a smile at club meetings and sit with her throughout the meeting. Get to know your new member by asking about her profession, hobbies, family and past experiences with nonprofit organizations. By doing so you can then suggest she join one of the committees to start getting involved with volunteer work. Keep in mind that, as a mentor, you become part advisor, teacher and counselor, all rolled into one.

Here are a few suggestions to focus your thinking as you prepare for your conversations:

- **Be clear.** Listen with intention when finding out why the new member joined and what she wants to get out of the club. Offer to walk her through the many different opportunities available to her.
- **Set a realistic goal.** Find out if the new club member is dedicated and willing to set aside a certain number of hours per month to volunteer in order to make a difference in her community.
- **Create a timeline.** Determine how soon the new member can join a committee, and stick to it by getting the chairman involved by adding her to the email distribution list and inviting her to a meeting. Holding a person accountable can lead to success. Follow up every so often to ensure she is happy in her new role.

Bottom line, being a mentor is like making a new friend. It is a two-way relationship that requires time and patience. Each mentoring partnership is unique, and you may choose to get as involved as you wish. When the new member is off and running, you can proud of your accomplishment and celebrate her successes along the way. A thoughtful thank you note, birthday e-card, and kindness goes a long way. Become a mentor and enjoy the journey!

Reporting is a wonderful way to document club activities and share that information with others. It is valuable for recognition and history and can be an easy activity if advance planning is done.

We want to know what your club does and we want to celebrate your successes with you! We are so grateful to the clubs who always report – your efforts are truly appreciated! If your club doesn't report, please consider picking an event your club really enjoys and report on that. If the narrative seems overwhelming, report your statistics. Start simple. Pick one project and tell us what you did. Your community work is valuable and we would love to hear about it!

# The reporting period includes club activities from January 1, 2019 to December 31, 2019.

Deadline for submitting reports is 11:59pm on January 24, 2020.

#### 1. Who should submit reports?

EVERY club! Reports are an excellent way to keep history of your club for future club members. Reviewing the previous year's events gives members a better idea of how much they accomplished for the year. They are great member recruiting tools and can be used to show prospective members all the wonderful things you do for your community.

#### 2. Is the President of the club the only person who can write reports?

No! It's up to each club how to handle reporting but one suggestion is to make it a fun activity by having members get together to prepare the reports. Enjoy snacks and drinks!

#### 3. When are reports due?

Reports must be emailed or postmarked no later than January 24, 2020.

#### 4. To whom should the Clubs reports be emailed or sent?

### **Club Reporting - FAQ continued**

#### 5. How long should a report be?

As long as it takes to paint a picture of your project in words. Be concise, without being repetitive for each GFWC Program. Include photos... Remember "A picture is worth a thousand words".

#### 6. What information should be included in a report?

Reports should include complete details outlining how many members participated, how many hours, how much was spent or donated, to whom it was donated—who, what, when, where and why. The reports can also include a narrative describing the project.



#### 7. What is a "narrative" in a report?

A narrative is a descriptive paragraph all about the project. It's a story about what was done. Some clubs only submit statistics while others will include a description of their project/s.

# 8. What is the difference between a Community Service Program and a Community Service Project?

The Community Service Program is the general designation of the six areas that clubwomen work within: Arts, Conservation, Education, Home Life, International Outreach, and Public Issues. Within each of those Community Service Programs are two categories—Community Service Projects or Partnership Projects. For example, hosting a "Red Dress" dinner to raise awareness of the effects of heart disease in women is reported as a Community Service Project in the Home Life Community Service Program while work with Canine Companions for Independence is a Home Life Partnership Project.

#### 9. Should each GFWC Program be a separate document?

Yes! You need to have a separate document for each program. You can have all like projects in the same document but, each program needs to be a separate document. Example: Your club reports on Arts, Conservation, Public Issues, Leadership, Membership, Fundraising & Development and ESO, for a total of 8 Program reports. Why? Because each program has a different State Chairman and your clubs reports will be sent on to the State Chairmen for review. If the Program reports are not in separate documents your clubs numbers will be counted in the total but will not be accepted for awards.

#### 10. Where do we get the information for the reports?

Information is found in meeting minutes, newsletters, project wrap-ups, treasurer's reports, and member activity reports. Chairmen of all club projects should turn in a report as part of the permanent record of the club. The project report should include complete details outlining how the project was implemented, hours worked on the project, monies raised or donated and any in-kind donations. Then it's only a matter of "cut and paste" into your reports for GFWC.

#### 11. Why should I submit Club reports electronically?

It saves time, money and is environmentally friendly. Just remember the reports must be submitted no later than 11:59p on January 24, 2020.

#### 12. Where can I locate copies of the statistical form?

An electronic fillable version of the Statistical Form will be available on the State website at www.gfwc-wi.org, via email janicemcurtiss@gmail.com or by calling Janice at 920-838-2007.

#### 13. Can my report include pictures?

Absolutely!! "A picture is worth a thousand words." To save space and stay within your 2 page maximum, wrap your text around the pictures, adding them as part of your narrative.

#### 14. How do I determine the value of an in-kind donation?

If the item was brand new, the cost of that item is recorded as the value. If the item is used, do your best to value the item like a resale shop would. The dollar values are recorded as in-kind.

## 15. I have submitted reports in the past, but I'm sometimes confused about where to record a project. How do I know what Community Service Program to use?

This is always a dilemma because a project can usually fit in more than one Community Service Program. For example, doing crafts with children at a domestic violence center could be Arts or Domestic Violence. Use the information in the GFWC Club Manual https://www.gfwc.org/newspublications/club-manual/ and place it in the Program your Club feels passionate about.

#### 16. Can I report a project in more than one category?

No, you must select either one Special or Community Service Program or one Advancement area.

Note: The only exception to this is the Community Improvement Program (CIP) Award, these Projects can be reported in your yearly report as a Community Service Program as well as entered for the CIP Award. Remember: CIP Projects MUST be accomplished during the program period: January 1, 2018- December 31, 2019. See specific instructions on the GFWC.org website in the 2018-2020 Club Manual, Awards, Contests and Grants tab or contact Tari Wallner; Community Improvement Program Award Chairman

#### 17. Do I need to send reports directly to GFWC Headquarters in Washington, DC?

No, we are saving you postage and paper! Your reports are compiled at the state level and that info is sent to GFWC so you don't have to!

#### 18. Are there any other changes this year?

Yes! I'm working on creating fillable forms for you to use. They will be available on the GFWC-WI website for you to use for your club reports.

I look forward to all your reports! Please contact me if you have any questions or concerns...I'm here to serve you.



# New Club Year Reminders:CONDUCTING A REGULAR BUSINESSMEETINGExcerpts from GFWC September Leadership Newsletter

When preparing to conduct the club's regular meeting, the president should create an agenda for herself and the secretary. If the president is new, inexperienced, or insecure, preparing a more detailed agenda is invaluable in conducting a successful meeting. It provides the support needed for the president to lead well, and members have a great sense of accomplishment from participating in a well-planned meeting. A simple meeting agenda should be prepared for the members and distributed at the opening of the meeting.

The following basic agenda provides a good starting point. Other items of business or reports may be included as necessary.

<u>Call to Order by the President.</u> At the appointed time, the president makes one rap of the gavel. President: "The meeting will come to order."

**Opening Ceremonies.** This could be a simple prayer or invocation prior to reciting the Pledge of Allegiance to the Flag of the United States of America. Roll Call is optional, but if it is a club custom, the secretary should call the roll. The president declares whether a quorum is present or not.

**Reading of the Minutes of the Previous Meeting.** President: "The secretary will read the minutes of the previous meeting." The secretary reads the minutes. President: "Are there corrections to the minutes?" (Pause) "They are approved as read (or as corrected)." Note: Do not ask for corrections or additions, as additions are corrections.

**<u>Correspondence</u>**. The secretary or corresponding secretary, if there is one, reads the correspondence. Action on matters of correspondence is generally considered in new business.

**<u>Reports of Officers.</u>** If officers have special assignments or tasks, they would generally report on those matters in the order as listed in the bylaws.

**Treasurer's Report.** President: "The treasurer will give the treasurer's report." (Treasurer reads report). President: "Are there any questions?" (Pause) "The treasurer's report to be placed on file."

**Recommendations of the Board of Directors or Executive Committee.** The secretary reads the recommendations and action is usually taken either at this point or in new business. A second is not needed as the recommendations come from a group.

**<u>Reports of Standing Committees.</u>** The Chair calls upon them in the order in which they are listed in the club bylaws. No action is taken unless a recommendation is made.

**<u>Reports of Special Committees.</u>** The Chair calls upon them in the order in which they were appointed. These committees were appointed to do a specific job and are automatically dissolved when the work is finished and the final report is given.

**<u>Unfinished Business.</u>** The minutes of the previous meeting show if there is business postponed by a motion or left unfinished. The Chair never asks if there is unfinished business. She should know.

**New Business.** This is business that has not yet been discussed. It is introduced by correspondence, recommendation, the Chair, or any member. A motion should be made to bring the matter before the organization for discussion.

#### Announcements.

**Program.** The president or program chairman may present the program. The president never "turns the meeting over" to anyone but rather announces the chairman who, in turn, presents the program. The president thanks the speaker.

**<u>Adjournment.</u>** President: "Is there any further business to come before this meeting?" (Pause) "If not, the meeting is adjourned." Adjournment may be made by a motion, which is not debatable.

#### DUTIES OF THE CLUB PRESIDENT Excerpts from GFWC September Leadership Newsletter

1. Presides at all meetings and uses a written agenda to maintain focus.

2. Must have basic knowledge of parliamentary procedures and how to maintain order.

3. Arrives at the meeting location ahead of time to be sure everything is ready.

4. Calls meetings to order on time and identifies if a quorum is present.

- 5. Announces the business before the assembly in the order it is to be acted upon.
- 6. Recognizes members entitled to the floor.
- When two people try to obtain the floor at the same time, preference is given to the one who has not previously spoken.
- The president should alternate from those who oppose and those who are in favor of the motion.

7. Makes parliamentary decisions and rulings based on the rules and adopted parliamentary authority. Advice may be sought of the parliamentarian, but the decision is that of the president.

8. Does not use the personal pronoun but refers to herself as "The Chair" while presiding. Additionally, she does not refer to "my Board."

9. Reports in third person, using "This officer" and "Your president" instead of the personal pronoun.

10. Votes as any other member in a ballot vote, may vote to break a tie in a voice vote, and cannot break a tie in a ballot vote.

11. Leaves the Chair to debate. She never debates from the Chair. She will not resume the Chair until after the vote is taken.

12. Should be firm, competent, tactful, and fair. Being neutral from the Chair on controversial matters will allow for thorough discussion on motions.

13. Does not "turn the meeting over" to anyone, but rather announces that the program, etc., will be presented by the person whom she names.

14. Performs all duties specified in the organization's bylaws and/or standing rules.

15. Represents the organization at district, state, region, and national meetings.

16. Prepares a procedure book to share with her successor and leads other leaders to do the same.

Try doodle - they will help find the best time for everyone to meet. You send available dates/times and responders enter their name and check off when they are available. You can see at a glance the best time to meet and better yet it is FREE.

**Google Voice** - Does your club post a member's phone number on the website, Facebook page or club brochure? Do you feel like that number is exposed to robocalls and unsolicited telemarketers? With a Google phone number, the administrator publishes the Google number as the

club's phone number. The calls are then forwarded to the 'real' number. The club's social media administrator can pass the sign-in information to her successors when the time is over guaranteeing continuity for telephone contact. -More on next page-

**Otter.ai** - Are you worried about being club secretary and not getting everything reported? Otter.ai might be your answer. It is a transcription software that works on our computer or phone. It can transcribe during real-time, identify speakers and so much more. Best part it is FREE with 600 minutes/month.

**Pingg.com** - Are you looking for a way to RSVP for club meetings or sell tickets to your upcoming fundraiser? Pingg.com is a great alternative. Depending how you would like to utilize this site, it can be free or cost \$10/event or \$30/year. It allows you to create a custom URL to attract donors to purchase tickets for your fundraiser.

**Signupgenius.com** - Gone are the paper sign-up sheets passed around meetings and missing members because they weren't there. Signupgenius.com allows you to create shifts for the upcoming bake sale or hostess duties for the whole year. Best part it sends reminders, lets you know when someone signs-up and it is FREE!

**Team App, GroupMe or Remind** - Looking for an easy way to send and receive instant messages with club members? These three are all free apps and there are a few more out there too.

**Techsoup.com** - Is your club a non-profit and you are looking to purchase a laptop for club use or even some accounting software like Quickbooks to simplify treasury duties? Techsoup.com is the website for you. Take a look and save some money.

#### GFWC - WI Junior Women's Clubs Proposed By-law and Policy Changes

To be voted on at the Fall Workshop October 12, 2019

#### **ARTICLE VII. OFFICERS**

**Section 1.** The Officers of the organization shall be comprised of the Director of Junior Clubs (hereinafter also referred to as the Junior Director), the Director-Elect of Junior Clubs (hereinafter also referred to as the Junior Director -Elect), and the Junior Secretary/Treasurer.

#### **Recommended changes:**

Delete (hereinafter also referred to as the Junior Director)

Delete (hereinafter also referred to as the Junior Director-Elect)

Strike Secretary/Treasurer and replace with Secretary and Junior Treasurer.

If amendment is adopted, replace all Junior Directors references with Director of Junior Clubs and replace all Junior Director-Elect references with Director-Elect of Junior Clubs throughout the Bylaws.

**Rationale:** To be consistent throughout the bylaws and in compliance with GFWC. To show that Secretary and Treasurer are separate officer positions.

If amended would read:

Section 1. The Officers of the organization shall be comprised of the Director of Junior Clubs, the Director-Elect of Junior Clubs, and the Junior Secretary and Junior Treasurer.

- a. \$ 20.00 for the Junior Director-Elect, payable only at the end of her first year.
- b. \$ 20.00 per year each for the Junior Secretary, Junior Treasurer, Junior Membership,
- c. Junior Special Project, Junior Leadership, Junior Fundraising and the Junior Bylaws Chairmen. (The Bylaws Chairman's desk allotment shall be payable only if the committee is active during the year).
- d. If the Junior Secretary and Junior Treasurer position is held by the same person, she shall receive only one desk allowance of \$20.00.

#### **Recommended changes:**

Combine b and c. Re-letter d to c.

Rationale: C is a continuation of b, thereby needing d to be re-lettered to c.

If amended would read:

#### 11. There shall be desk allotments payable as follows:

- a. \$ 20.00 for the Junior Director-Elect, payable only at the end of her first year.
- b. \$ 20.00 per year each for the Junior Secretary, Junior Treasurer, Junior Membership, Junior Special Project, Junior Leadership, Junior Fundraising and the Junior Bylaws Chairmen. (The Bylaws Chairman's desk allotment shall be payable only if the committee is active during the year).
- c. If the Junior Secretary and Junior Treasurer position is held by the same person, she shall receive only one desk allowance of \$20.00.

The road to a bill requiring schools to reintroduce cursive writing has been long and winding, but we appear to be making good progress with the help of Representative Jeremy Thiesfeldt, Chair of the Assembly Education Committee and Senator Luther Olsen, Chair of the Senate Education Committee.

Rep. Thiesfeldt is presenting the draft of his bill to committee soon and after their review it will be assigned a bill number. After we know the bill number that is when we should start writing letters and really putting on the pressure. The

next phase would be the public hearing and it is our hope that MANY GFWC members are able to visit Madison to show our support. I will keep you posted on the bill.

#### HERE IS HOW YOU CAN HELP

We have 308 petition signatures to date and wish to thank all the clubs as well as women outside of our organization. They will be presented to Rep. Thiesfeldt. #### From cover story, "Why Didn't You Just Leave?"

...friends and family will judge her. Some women may feel sorry for their abuser and feel that they can help them or change them. And many women, like me, were also financially abused where the abusive partner makes their victim financially dependent on them. Without money, access to resources or even a place to go, it can seem impossible for them to leave. This creates a strong



feeling of helplessness. I have experienced all of this. I was isolated from my family and knew the trouble I would face if I tried to have any friends. I was completely isolated and alone.

Even though I am out of this abusive relationship, I still struggle. I'd like to say that this is all over, but it will always be a part of me, but each day I am getting better. I hate to think of myself as a victim. It didn't end when I walked away. In a small town, I have weak moments when it is hard to keep my head up and face my community.

When he loses control of you, he will try to control everyone that knows you. The most heartbreaking aspect of abuse is that after escaping the most torturous, malicious and damaging abuse, all you want to do is recover, pick up the pieces of your life and move forward.

An abuser fears two things: 1. Losing Control and 2. Being exposed.

You need to overcome your fear and TELL everyone; a friend, your cleric, your doctor, the hospital, the police, a relative, 911, an abuse hot line; and keep telling till you get the help. Often when a woman does report or speak of domestic violence, her words are discredited or dismissed. I have often wondered: Did they see my truth and remain quiet or did they just see what they what wanted to see. If they only knew what I endured.

Domestic Violence is a serious issue that many deal with and keep hidden.

We need to LISTEN with our ears and our hearts. If we don't listen to survivors, they won't report and abuse will never end. -Thoughts from anonymous survivor of domestic violence
