


Message from our 2018-2020 GFWC - WI Director of Junior Clubs


Treasury work completed since the 2019 Fall WI Clubwoman includes the following:

• Received rosters from all clubs. The rosters were requested in Excel format by October 20. The rosters were received in Excel, Word, handwritten, and over the phone formats. Many clubs continue to have missing information for phone and emails. The stats for the files are:

• Rosters are used for determining membership and voting credential totals for GFWC and GFWC-WI as well as for assembling communication data files for mass mailings or for email distribution for GFWC-WI. The rosters were transcribed as needed to an Excel format file and were then converted to a common format so they can be used to extract a mail or an email database.

Emails were given to Erin Epping, the GFWC-WI Webmaster to create an email database. Throughout the past year, the treasurer has followed up with clubs for erroneous member emails. There were 22 email errors with the October notice as compared to 123 errors with the first attempt at mass email notices to members. The treasurer and webmaster continue to clean emails as errors become known.

Efforts to have accurate emails puts GFWC-WI in closer alignment with the 2014 bylaws changes requiring an electronic version of the GFWC-WI Clubwoman and ensuring members receive this as part of their dues.

The next major email update occurred with the Fall 2019 roster updates.

- The FY2018-2019 Federal Tax Form 990EZ and State Form 5 were completed and filed on time.
- Recorded the transactions of the organization and generated financial reports reconciled to the cash and investments accounts since the Executive Committee Meeting in September 2019.
- All investment accounts are recorded and reconciled between Quicken and Morgan Stanley Statements through October 2019.

The Treasurer is an active participant in these committees: Executive, Health Scholarship, Investment Budget, Amendments and Policies, Communications & Public Relations and the Wisconsin's Own Library. All but the Budget Committee has had one or more meetings, conference calls or email exchanges since the Fall Junior Conference.

Thank you to all the club presidents and treasurers who responded so willingly with the rosters.


District Report - Rivers & Lakes District



3 Tips to Increase Membership

It is common for clubs to have trouble attracting new members. Perhaps it is even more difficult to find younger members. Recruiting new members is possible and here are a few tips to help you get started.

1. Make it Simple

It is important to make the application process as simple as possible for a prospective member. Consider printing a tri-fold brochure that has an application form in it. Keep your brochures with you at all times so that you can simply hand one out when you meet a potential member. Younger professionals may Google your club and search online for your website to learn more about GFWC and your club. If you don't already have a website, you may want to engage a niece or nephew to create a website for your club. Once you have a website, creating an online printable membership application form (along with PayPal or another web-based payment system) can make it easy for prospective members to join. Make it simple with as few steps as possible and clear instructions. A simple sign-up process is crucial for attaining new members.

2. Know the Value of GFWC

Review the many GFWC benefits and make sure they are high-lighted and communicated clearly on your marketing materials and website. Details about joining should be easy to find, listing your membership fee and monthly meeting dates. In addition to sending out e-blasts to your members, be sure to include opportunities to connect with other members in order to encourage networking that could make a difference in their professional life or business. Offer to answer questions and encourage new members to connect with existing clubwomen to help them learn about opportunities for involvement.



3. Host a New Member Drive

It is common for women to make decisions based on emotion. A social event will provide a unique opportunity to connect with prospective members on a personal level. Whether you host a wine tasting event, pizza party or book club, women are looking for experiences that are memorable and create a feeling of belonging. A new member drive held during your existing annual fundraiser or special event is a perfect opportunity to share the benefits of GFWC and the good work you do in your community. Invite a member to give a testimonial about their experience. Not only do people like to talk about themselves, but we all love to hear a good story!

At your next club meeting, add membership to your agenda. Take the time to strike up a conversation about how many members to attract and specify a date to host a new member drive. Before you know it, your club will be attracting new younger members to mentor to take on leadership positions. You can do it!

GFWC Leadership Education and Development Seminar (LEADS)

Information for GFWC State Federations – Customized for GFWC-WI 2018-2020

The GFWC LEADS program is intended to identify GFWC members at the grassroots level who have the potential and the desire to assume leadership positions in GFWC beyond their club. Participation in GFWC LEADS can help these members gain the capabilities, confidence and commitment necessary to pursue and achieve higher office and serve with distinction. The LEADS program is held annually (Friday, June 26, 2020) the day before the official opening of the GFWC International Convention (Saturday, June 27 – Monday, June 29, 2020 in Atlanta, GA). LEADS is a full day of activities, and includes breakfast and lunch. A graduation ceremony is held at the conclusion of the day-long program.

Some important details are as follows:

- One attendee each year from each State Federation is eligible to participate in LEADS.
- GFWC will cover a portion of the attendees' expenses, including:
 - Round-trip travel to and from the GFWC Convention city, up to \$250

 Lodging allowance of one-half of room charge for two nights at official Convention hotel

 Breakfast and lunch during the LEADS program
 - Checks will be distributed to candidates upon attendance and completion of the seminar.
- State Federations may consider underwriting a portion of attendee's expenses (i.e. additional lodging, meals, or Convention registration). *GFWC-WI supports our candidate by underwriting up to \$750 of eligible expenses*.
- LEADS attendees are expected to be responsible for a portion of their expenses as an affirmation of their personal commitment.
- •The LEADS participant is responsible for making her own travel and lodging arrangements.

 (Note for GFWC-WI: In prior years a LEADS welcome reception occurs on Thursday evening and a LEADS breakfast occurs on Saturday morning. Watch for details regarding these events in the convention program and plan your travel accordingly.)

CONTENT & PRESENTATIONS AT LEADS

LEADS may include the following:

- Presentations on conflict resolution, mediation, public speaking skills, time management, parliamentary procedure
- Explanation of GFWC resources, materials, and assistance
- Discussions on GFWC policies, procedures, and parliamentary law
- Tips and techniques for pursuing leadership opportunities

CRITERIA FOR PARTICIPATING IN LEADS

It is highly recommended that each state candidate for LEADS:

- Demonstrates leadership capabilities at the club level as an active club president, club officer, or club project or committee chairman.
- Exhibits a commitment to Federation.
- Exhibits an understanding of the GFWC mission of community service, illustrated by programs and projects in which she is or has been involved.
- Demonstrates leadership skills, including, but not limited to, organization, responsibility, trustworthiness, enthusiasm, and flexibility.
- Exhibits an interest in and willingness to pursue higher leadership positions in Federation.
- Understands and accepts potential expenses involved in participation.
- Has not held elected positions at or beyond the state level. This criterion is recommended in order to encourage potential leaders at the club level to apply.
- Has not attended a previous LEADS program. Members are eligible to attend only once.
- Agrees to share information gained from participation in LEADS with others in the state.
- Agrees to the following additional criteria established for GFWC-WI:
 - *Agrees to serve and actively participate on the GFWC-WI Leadership Committee and contribute to the GFWC-WI Mini LEADS Presentation Team.
 - *Beginning in 2020, preference in the selection of the GFWC-WI LEADS candidate will be given to GFWC-WI Mini LEADS graduates.

ADVANCEMENT AREA: COMMUNICATIONS & PUBLIC RELATIONS

SMALL PROJECTS, BIG RESULTS!

Communications and Public Relations is a vital part of our GFWC livelihood. Sometimes we wonder how the clubwomen in the early 1900's got the word out to members. Now we have so many different ways to communicate with our members and the public. GFWC President Mary Ellen Brock's Grand Initiatives are an important part of her administration. An example of using your communications and public relations is stated below.

"We are such a small club (membership of six), what can we do to make a difference?" As their advisor some hints were given which they took to heart and put to good use.

While shopping they informed people everywhere that they purchased Dr. Seuss books and told them why they were buying the books and where they were going to be donated when taken to the GFWC Annual Convention.

The club began gathering shoes and donated them to Soles4Souls, explaining to those donating about this project.

For their last project they gathered over 20 gowns plus accessories and took them to the local air base for the military women, explaining to them the Grand Initiatives for GFWC.

They accomplished three of the seven initiatives. This could be considered a **BIG** result from a small club.

DON'T FALL FOR THE WRONG CAN OF SPAM

Spamming ~ Phishing ~ Hacked ~ Spoofed

Communications and Public Relations is important in our club world. However, we need to worry about what the "bad guys" are searching for and sending us in order to get into our email and website.

Spamming is an unsolicited email. It is often an advertisement, a subscription offer, or a newsletter. They are annoying, but they are typically harmless. Just do not open them.

Phishing is an attempt to gather your personal information, passwords, etc. They are vague or they will warn you that something good or bad will happen to you if you do not respond. They may pretend to be from a commonly used company or service - UPS, FedEx, Amazon, Chase Bank. They will often times have some form of bad grammar as a clue to them not being legitimate. It may also have links that redirect you to fake data gathering web pages. They also commonly use classified ads, such as Craig's List to start an interaction with you.

<u>Hacked</u> is when an unauthorized user(s) attempt/s to access your account. Some signs may be that the contacts say they are receiving emails from you, or you start receiving mail delivery failures. There can be messages in your "Sent folder" that you did not send and there can also be activity pages/logs show logins from places and times you did not do.

Spoofed is when someone sends an email with your name in the "From" field using an account that is not associated with you. Some signs that this is happening may be that your name is John Doe and your email address is johndoe@gmail.com, but people are receiving emails that show "John Doe" as the from name, but the email address shown isn't johndoe@gmail.com. **NOTE: This spoofing issue has been happening to President Deb Brossard; Deb said she will NOT be asking any of you for money, gift cards or favors.**

When in doubt, do not open anything. A simple click can cost you a lot and make you frustrated.

Dear Representative Thiesfeldt:

I would like to have your support in scheduling public hearings for the cursive writing bill AB 459. It is currently in the Education Committee and I am anxious for it to get approved.

I am a member of the General Federation of Women's Clubs (GFWC) in Wisconsin. The organization is the world's largest women's volunteer organization. There are members in all 50 states and in 11 countries with a membership of 80,000. GFWC-WI has 1,600 members statewide.

In May of 2018 the GFWC-WI membership voted on the following resolution at our state convention:

RESOLVED, the General Federation of Women's Clubs-Wisconsin supports the reinstatement of Cursive Handwriting instruction in the Wisconsin Department of Education public school curriculum.

Recently sixteen states or cities have passed bills to reinstate cursive writing. They are Arizona, Louisiana, Ohio, Arkansas, Virginia, California, Florida, Texas, Tennessee, New Jersey, Indiana, Alabama, Massachusetts, Georgia, North Carolina, and New York City.

The benefits of teaching cursive writing are numerous. A few of them include:

- Helping dyslectic and autistic students
- Helping students retain more with handwritten notes rather than keyboard
- Improving hand eye coordination; for example, a doctor in a medical school laments the fact that students in surgery lacked the hand eye coordination to properly perform surgeries.
- Having the ability to read cursive documents such as our Constitution
- Enabling them to sign their names on important documents.

I look forward to hearing from you about this important matter.

Congratulations on a wonderful start to another successful club year. I will again ask you to support the photography

contests by capturing each "moment in time" regarding your outstanding club work. The old adage states, "a picture is worth a thousand words." We want you to capture those moments of volunteer service while helping showing your community the many diverse projects and worthwhile causes that we support throughout Federation.

This year, GFWC received 44 photographs from clubs for the Year in Pictures Contest. If you will remember, each club is allowed to submit one photograph for this calendar contest. I ask that each of you help promote this contest and encourage all clubs to submit an entry. That entry number would be much higher if more clubs took advantage to the opportunity to display their talent.

Additionally, from the states, 31 photographs for the Volunteers in Action Contest along with 38 Scenes, 38 Living Things, and 31 Still Life photographs for the World in Pictures Contests were received. The judges did note a couple of issues with a few of the submissions. It was noted that labels were not affixed to the back of the photograph designating the category of the picture. Additionally, some of the photographs did not have all of the required information noted on the label. Please help reinforce the guidelines so that all photograph entries can be considered.

I would also ask that you stress your state contest guidelines to the clubs and clubwomen across your state. The calls that I received mostly involved questions about the state or district process. I did refer the clubwomen back to the state chairman or president to officially answer the questions since I am certainly not knowledgeable with specific state guidelines. There are many different state guidelines. For example, one state has a separate contest for black and white photography. Each state can have any contest that they would like. The black and white photographs are not separate at GFWC, so that state would need to select the one photograph that they would like to submit for each contest.

Thank you for helping encourage our members to display their many talents. Hopefully, the pictures will continue to allow others to see the outstanding volunteer work that is completed by our fellow GFWC clubs and club members. Next spring, let us fill up GFWC Headquarters with photographs!

Q & A - GFWC PHOTOGRAPHY CONTEST

Submitted by: Tammie McCoy, GFWC Photography Contests Chairman

Fellow clubwomen, I have compiled a listing of frequently asked questions and answers. I hope that you find them helpful. As always, thank you for capturing your "moments in time". Call or email me anytime!

Q. Where should clubs send photographs to enter The World in Pictures Contest and GFWC Volunteers in Action Contest photography contests?

All clubs should follow their STATE photography submission guidelines for The World in Pictures Contest and for the GFWC Volunteers in Action Contest.

Q. Where are the state federation guidelines found?

States set their own criteria as to how the photographs are judged. Some judge at district levels and then judge at the state level. Other states only have judging at the state level. States may provide information about the process in the state club manual, other communications, or on the website. The state leadership decides how to publicize the contests.

Q. Who can provide the state federation guidelines?

Club members should contact the state photography contests chairman, the state president or junior director for state specific directions. Suz Hooser is GFWC-WI Member Arts & Photography Chairman, suzhooser@yahoo.com.

Q. Who sends the photographs to GFWC for The World in Pictures Contest and GFWC Volunteers in Action Contest?

Either the state chairman or the state president since the photographs follow the state judging process.

Q. Where are GFWC for The World in Pictures Contest and GFWC Volunteers in Action Contest photographs sent?

These state winners are not mailed to the GFWC chairman; each photograph should be mailed directly to: GFWC

Each contest photograph(s) should have the appropriate designation such as GFWC WORLD IN PICTURES CONTEST or GFWC VOLUNTEERS IN ACTION CONTEST

Q. What forms have to accompany the photographs?

All photography must have the GFWC Creative Arts Waiver submitted along with the photograph. (ATTACHED)

States should include a cover letter with a listing of the photographs and the designated entry area which will be either GFWC WORLD IN PICTURES CONTEST (Living Things, Scenes, Still Life) or GFWC VOLUNTEERS IN ACTION CONTEST.

THERE IS NO SPECIAL FORM for the cover letter.

Q. How many subcategories are there for GFWC Volunteers in Action?

There are no subcategories for this contest. EACH STATE may submit ONE photograph for this contest.

Q. How many subcategories are there for The World in Pictures Contest?

There are THREE subcategories for this WORLD IN PICTURES contest. EACH STATE may submit ONE photograph for EACH area: Living Things, Scenes, Still Life. Therefore, each state can submit THREE photographs in this area.

MORE Q & A - GFWC PHOTOGRAPHY CONTEST

Q. Where should clubs send photographs for A Year in Pictures Contest?

Each club can submit ONE photograph directly to GFWC for entry into A Year in Pictures Contest (GFWC Calendar Contest). This is the only contest where clubs send photographs directly to GFWC.

Q. How does the club decide which photograph can be sent to GFWC for the A Year in Pictures Contest?

Judging for the one submission from the club directly to GFWC for A Year in Pictures Contest is done by the club. State federations do not have a part in judging for this contest.

Q. What forms have to accompany the A Year in Pictures Contest photograph?

Each photograph must also have the GFWC Creative Arts Waiver submitted along with the photograph.

Each club should include a cover letter with the notation that this is an entry for A Year in Pictures Contest. THERE IS NO SPECIAL FORM for the cover letter

Q. Where does the club send the A Year in Pictures Contest Photograph?

Q. Are there other guidelines to follow?

- Each photograph must be an 8 X 10 print.
- Each photograph must be mounted on a rigid board not to exceed 3/8 inch. No mattes, frames or hangers.
- Each photograph must have a label affixed to the back with the following information:

Contest name

Photographer's name, email address, mailing address, and phone number

Name and State of sponsoring club

Title and brief caption giving location, date, and other notes about the photo

Arrow indication the top of the photo

Q. Will the photographs be returned?

No the photographs will not be returned.

Q. Are there any other requirements"?

All photographers must be a dues paying member of an active GFWC Club.

Q. Can the same photograph be submitted to more than one category in a contest area?

Yes, as long as a separate photograph is presented for each category and each contest.



Words from a song many of us remember:

Pass It On
It only takes a spark

And soon all those around
Can warm up in the glowing...
You'll want to Pass It On.

The GFWC-Wisconsin Club Women are ready to pass on our spark. **The Turning Point Suffragist Memorial** will happen with our support. Wisconsin clubs and individual club members have given support toward placing our GFWC-WI name to a plaque that symbolizes the history of women all over the world.



<u>A SPARK</u> - July 13, 1848 - Lucretia Mott, Martha C. Wright, Elizabeth Cady Stanton, Mary Ann McClintock are invited to the home of Jane Hunting in Waterloo, New York. They decide to call a two-day meeting of women at the Wesleyan Methodist Chapel in Seneca Falls to discuss women's rights. July 19-20th 1848 - Three hundred people attend the first convention in Seneca Falls, New York, 68 women, 32 men signed the "Declaration of Sentiments".

<u>A FLAME</u> - January 8, 1868 - Elizabeth Cady Stanton, Susan B. Anthony, Parker Pillsbury published the First Edition of The Revolution which became one of the most important newspapers starting a state by state campaign. First year motto was "Principle, not Policy" second year motto "Men, their Rights and Nothing Less".

<u>A FIRE</u> - 1910: The First Suffrage Parade was held in New York City organized by the Women's Political Union. 1911: 3,000 suffrage supporters marched in the Second Suffrage Parade in New York City with an estimated 70,000 onlookers. 1912: 20,000 suffrage supporters marched the Third Suffrage Parade in New York City with an estimated 70,000 onlookers. 1913: The largest to date, 10,000 marched in the Fourth Suffrage Parade in New York City with 500 men, and an estimated 500,000 onlookers.

THE TORCH

It's up to every woman to carry this torch in learning about, educating and honoring the women before us. You still have time to support the Turning Point Suffragist Memorial — by club, district or yourself. The deadline is December 31, 2019. The Memorial group will accept a pledge to be paid off before the Memorial is dedicated on August 26, 2020. Appropriate donor form for this challenge is available through me.
