
personal development, new knowledge and rekindling of all those GFWC Sister connections.



The 2023 GFWC-WI Convention is ready to go! President Nancy Dick-

man and Director of Junior Clubs Suz Hooser set several innovative and exciting goals for their administration. In keeping with their promise of member education and advocacy, attendees will be inspired and activated by a series of very special speakers, touching on many aspects at the heart of GFWC.



The GFWC Signature Program will be highlighted by two speakers. Teri Jendusa Nicolai, now a Domestic Violence Prevention Advocate, will tell her story. She survived the unthinkable. Her ex-husband tried to murder her by beating her with a baseball bat, stuff-

ing her into a garbage can, driving her across state lines and placing her in a storage locker in sub-zero weather. Twenty-six hours later she was miraculously rescued less than an hour from certain death.



Trisha Shafer, current chair of GFWC Domestic and Sexual Violence Awareness and Prevention, will focus on the horrors of human trafficking and its startling increase in the United States.



Looking toward a lighter vein in Health and Wellness, Patricia Witkowski will enthrall the GFWC-WI women with the story of her solo hike of the Wisconsin Ice Age Trail. As only the 23rd person to complete, in one year, the entire 1,200 miles that runs through 31 counties of

the State of Wisconsin, she will highlight her story with striking nature photography of the trail in all seasons. Wearing her passion for the trail on her sleeve, her shirt, her hat and plastered all over her car, Pat will surely inspire the Wisconsin women to get out and walk in nature.



Environment will be highlighted with speaker Victoria Glenn Christensen, Ph.D. of the United States Geological Service. By day she is a geologist and hydrologist, at night she writes children's books about science and technology. Come hear her humorous approach to science.



In line with Education and Libraries, the women of Wisconsin will hear from the newly appointed Wisconsin Poet Laureate, Nicholas Gulig. As an associate professor of language and literature at University of Wisconsin-Whitewater, he loves to share his joy of poetry and his love of li-

braries with his students.



The Advancement Area speaker is Randall Bansley, of WI Department of Gaming who will speak on all things fundraising in WI. Most clubs will benefit from hearing firsthand the ins and outs of how to conduct compliant fundraising in WI. From licenses to reporting, Mr.

First, I wanted to THANK YOU for all of your hard work in 2022. What a busy reporting season you had. I couldn't believe all the reports I received and how creative all of you were. I'm excited to meet the winners at the State Convention in Eau Claire.

For the 2022 reporting year, we had 31 clubs report with 198 total projects, 10,377 volunteer hours, \$65,762.12 of donated funds and a total of \$23,389.50 of in-kind donations. WOW!! For my first reporting year, you all blew me away.

Did you know that Civic Engagement and Outreach focuses on Hunger in America. In the wake of the Covid-19 pandemic, unemployment and food insecurity soared. In 2021, 53 million people turned to food banks and food pantries. These community programs are a source of nutrition, and help put food on the table. Many households do not qualify for federal nutrition programs and visit food banks and food pantries for help. MANY have never had to use these services

before. One paycheck lost, one medical emergency, one transportation breakdown, the electric bill or gas bill goes up. Families cannot provide for their families. As part of Civic Engagement and Outreach, you could do a monthly drive for your local pantry. Make it fun and creative. An example of this would be to donate items that begin with the same letter as the month. Example: \*March-Macaroni\*April-Apples\*May-Mandarin Oranges\*

#### **March is Colon Cancer Awareness Month**

Colorectal Cancer Awareness Month is observed in March to demonstrate the importance of screening for colorectal cancer. It is also promoting healthy lifestyle habits that can reduce a person's risk of developing cancer of the colon, rectum or anus, the three distinct cancer types which are referred to as colorectal cancer.

Colorectal cancer is the third most common cancer type worldwide. It is the second most common cause of cancer death, despite the fact that effective screening techniques exist.

What can be done to decrease a person's risk for developing colorectal cancer? Intentional weight loss, physical activity and diets rich in fish, fruits and vegetables can reduce your risk. However, one of the most important things to do is to get your colorectal screening examinations. It is recom-

mended that for person's with an average risk of colon cancer that screenings begin around age 45. Colonoscopy examinations should be repeated every 10 years if there are no abnormalities found. There is also a Fetal occult blood test which is a non-invasive screening method and involves collecting a stool specimen and having a laboratory check for presence of blood in the specimen. This test however fails to detect some polyps and cancers.

So, please check with your provider and discuss with them the best method of screening for you. Also, try to follow some of the items mentioned to reduce your risk of developing colorectal cancer.

Did you know??

Lucy E. Smith Morris (1850-1935) was the first GFWC Wisconsin State President. Lucy was a native of Berlin, Wisconsin and served as your First State President from 1896-1898. Lucy E. Smith Morris brought local women's clubs into the Wisconsin Federation of Women's Clubs. Lucy at the very first meeting of WFWC, as a group made the decision to establish public libraries as their number one goal. The first free public libraries were established because of these Women's Clubs working together. And we continue today to support our local libraries throughout Wisconsin. Lucy Smith Morris was also very active in the suffrage movement. As you read the historical maker about her, she even had other well-known women of the suffrage movement to speak in Berlin and stay in her home.

If your club is looking for a field trip, plan on visiting Berlin to view the Lucy Smith Morris Marker. Her home, built in 1882 in the Queen Anne style still stands at 209 East Park Avenue.

**Looking ahead:** May of 2024 will be the 40<sup>th</sup> Anniversary of the GFWC Women's History and Resource Center which was founded in 1984 to collect, preserve, interpret, and promote the history of GFWC and women volunteers.

The resolutions committee welcomes the general membership to offer input. However, to ease the pressure on the tight schedule at the convention, the committee respectfully asks that if an individual or club wants to suggest an amendment, that she/they do so at or before the Resolutions Committee meeting that will take place on Thursday of the Convention. The Resolutions Committee will help write the

proper wording for the amendment in order to save time on the voting floor. Then the amendment can be presented without the delay of having to wait for it to be written out while the entire voting body waits, often not so patiently. It will also allow for the amendment to be presented on the screen for all to read. All amendments proposed must be in writing and have the name of the person and her club indicated on the amendment. If a member has a proposed amendment, please bring it to the Resolutions Committee meeting or submit it to the Resolutions Committee Chair, Nancy Niedziela via email. This will streamline the process for all members. The Resolutions Committee thanks you for your cooperation.

**VOTING** 

2023

#### WHEREAS the GFWC-WI believes that voter registration on Election Day causes

- increased voter confusion.
- unnecessary delays at the polls. increased opportunity for fraud, and

#### WHEREAS the current system of primary voting days across the nation

- disenfranchises voters whose voting days are held after other states' voting days;
- often limits voters' choices in certain states, and

WHEREAS voting is the right and responsibility of every American citizen; and eligible voters often fail to register to vote or do not vote on Election Day; therefore, be it

#### **RESOLVED** that the GFWC-WI urges its member clubs to

- 1. oppose voter registration on Election Day.
- promote education of the importance of voting and the electoral process.
- work toward the creation of a nationwide primary Election day.
- participate in voter registration drives.
- support the existing law requiring voters to show identification when at the polls when voting.

**RATIONALE**: To update, to strengthen, to eliminate duplication, to correct terminology, and to be more concise.

Should the new resolution VOTING be approved, resolutions #27 VOTER REGISTRATION, #28 VOTER ID, and #32 PRIMARY DAY shall be rescinded by substitution. All subsequent resolutions shall be renumbered.

#### 4. VEHICLE SAFETY - 2023

WHEREAS the use of alcohol is one of the leading causes of deaths and injuries on roadways; and

WHEREAS traffic accidents continue to take an unabated toll on lives and cause economic waste; and

WHEREAS there has been an alarming increase in automobile accidents caused by escalating numbers of inattentive drivers performing personal grooming, reading, talking, or texting on mobile devices; and

WHEREAS motorized vehicles are powerful machines which require full and undivided attention of drivers; and

WHEREAS periodic motor vehicle inspection provides a formalized method of discovering vehicle defects that contribute to traffic accidents and also provides for correction of such hazards; therefore, be it

RESOLVED that the GFWC-WI urges its member clubs to continue to

- 1. adopt, support, and help establish traffic safety programs such as "designated driver," "Ride Home," and Department of Public Instruction programs for teen drivers.
- 2. promote responsible motor vehicle safety legislation.
- 3. seek full enforcement and public cooperation with enforcement agencies.
- 4. support compliance with Federal and State safety standards.

RATIONALE: To update, to strengthen, to eliminate duplication, to correct terminology, and to be more concise.

Should the new resolution VEHICLE SAFETY be approved #4 DRUNK DRIVING; #10 HIGHWAY SAFETY; #12 INATTENTIVE DRIVING OF MOTOR VEHICLES; # 16 PERIODIC MOTOR VEHICLE INSPECTION shall be rescinded by substitution. All subsequent resolutions would be renumbered.

#### **HUMAN TRAFFICKING AND SEXUAL EXPLOITATION—2023**

**WHEREAS** according to the U.S. Department of State and UNICEF, human trafficking is a modern form of slavery, involving victims who are forced, defrauded, or coerced into sexual exploitation through pornography, social media, and prostitution, and

WHEREAS human trafficking is the world's fastest growing global crime and second largest source of illegal income worldwide, exceeded only by drug trafficking. Annually

- 1. Millions of children are trafficked worldwide.
- 2. Hundreds of thousands of men, women and children are trafficked across international borders.
- 3. Millions of people are victims of forced labor worldwide, and

WHEREAS the lucrative nature of the business has inspired criminal acts against mainly women and children including kidnapping, false imprisonment, and primary needs deprivation, and

WHEREAS the welfare of women and children is a prime concern to all levels of the GFWC; therefore, be it

#### **RESOLVED** that the GFWC-WI urges its member clubs to

- 1. educate members and the public about the seriousness of human trafficking.
- 2. advocate for the support and protection of victims and the prosecution of exploiters.
- 3. support law enforcement coordination between countries.
- 4. encourage mandatory enforcement of existing laws in the United States.
- 5. support legislation to ensure that products made by forced labor are not imported into the United States.

RATIONALE: To update, to strengthen, to eliminate duplication, to correct terminology, and to be more concise.

Should the new resolution HUMAN TRAFFICKING AND SEXUAL EXPLOITATION be adopted, #21 SEXUAL EXPLOITATION and #34 HUMAN TRAFFICKING shall be rescinded by substitution. All subsequent resolutions would be renumbered.

2011; Reviewed 2015, 2019; Amended 2023

WHEREAS bullying can be any verbal, written, or physical act that intentionally causes mental or physical harm; and

WHEREAS bullying can also occur through electronic means, cyberbullying via social media outlets such as You Tube, Google Classroom, TikTok, Snapchat, Facebook, Instagram and all such sites that exist now and may exist in the future, and such as internet, cell phone and other electronic devices; and

WHEREAS bullying can cause long term negative physical, social, and mental health issues (depression, anxiety, sleep difficulties, stomach, and other organ illnesses and more) and has been identified as a contributable cause of youth suicide and lower academic achievement; therefore, be it and

WHEREAS kids who bully others may also engage in violent and other risky behaviors as teenagers and into adulthood such as alcohol and drug abuse, vandalization of property, criminal convictions, traffic citations, and more, therefore, be it

**RESOLVED** that GFWC-WI urges its member clubs to promote community education about the seriousness of bullying; and further

**RESOLVED** that GFWC-WI urges its member clubs to support legislation to increase resources for prevention of bullying.



- 2. urge rigid enforcement of all laws regulating the production, sale and distribution of drugs and alcohol.

WHEREAS prescription opioids can be necessary and effective pain-management aids for cancer, surgical recovery, and painful chronic diseases; therefore, be it

**RESOLVED** that the GFWC-WI urges its member clubs to advocate for

- 1.development of educational awareness programs for providers, patients, and the community about the benefits and risks of opioids.
- 2.development and implementation of a national PDMP.
- 3.funding for all first responders to carry naloxone to be used to reverse an opioid overdose.
- 4.insurance coverage for naloxone for all individuals with an opioid prescription.
- 5.ready availability, which does not create an unnecessary burden or impediment to patient care, or prescription opioids for cancer, surgical recovery, and painful chronic diseases.

**RATIONALE:** to replace GFWC-WI Health and Wellness #15 OPIOIDS and to strengthen, update, broaden and clarify.

This is GFWC Resolution 015-830 adopted 6/20/22. The only changes being replacing GFWC with GFWC-WI and adding the words "but not limited to."

Should the new #15 OPIOIDS be adopted, the original #15 OPIOIDS shall be rescinded by substitution.

Any registration fee remitted after the deadline date shall include a late fee, the amount determined by the Executive Committee.

Section 4 – In the event of registration cancellation, the registration fee shall not be returned to the club member.

**Proposed Change:** Add a new section 5 that reads: Section 5 - In the case of a national emergency, state emergency, or any type of event that could potentially put members in danger, the President, with the consent of the majority of the Executive Committee, may order that an electronic meeting be held as a substitute for a regular Executive Committee, Board of Directors, or special meeting.

#### If amended would read: Article IV – Meetings

Section 1 – A regular meeting of GFWC-WI shall be held annually in the spring unless otherwise directed by the Board of Directors, the time and place to be determined by the Executive Committee, and this annual meeting shall also be known as the Annual State Convention.

**Rationale:** To clarify whose bylaws are to be approved.

#### **Current Article V - Membership, Section 3**

**Section 3** – Juniorette Clubs shall be composed of young women through high school age, working with the GFWC-WI and Junior clubs in their respective area on GFWC programs.

**Proposed Change:** Delete the word young women in line one and insert "youth attending middle school and high school".

#### If Amended would read:

Section 3 – Juniorette Clubs shall be composed of youth attending middle school and high school, working with the GFWC-WI and Junior clubs in their respective area on GFWC programs.

## **Proposed Changes:**

In line 2 delete "be responsible for filing the annual corporation report with the Secretary of State." and insert "ensure the Treasurer has filed all appropriate Federal and State reports and forms annually. Delete the last line of Section 2

#### If Amended would read:

Section 2 – The First Vice President shall be Dean of District Presidents. She shall ensure the Treasurer has filed all appropriate Federal and State reports and forms annually.

**Rationale:** The substitution is to conform with the current practice. Beginning in July of the odd numbered year of the administration, the First Vice President is preparing for her upcoming administration. Membership is an important committee and deserves the chairman's complete attention. This change with the provision that it will become effective with the 2024-2026 Administration. This will be done by a motion to the membership prior to the discussion of the proposed amendment changes.

#### **Article XIII – Officers' Expenses**

**Section 5** – Expense vouchers must be submitted before the end of the fiscal year which is June 30. Late vouchers will not be accepted or paid.

#### If Amended shall read -

**Section 2.** The Chairmen and membership of these committees shall be appointed by the President in accordance with other provisions within these bylaws and the approval of the Executive Committee. Where possible, a Junior member shall be appointed to programs, projects, and Class B Standing Committees."

Rationale: to clarify and update to current practice

**Section 10** – The Resolutions Committee shall consist of a Chairman and two members. The two members shall be members of the Board of Directors. The Parliamentarian or a Parliamentary Advisor shall be an advisory member of this Committee. Eight copies of each resolution must be submitted to the Chairman by the date designated by the Executive Committee. The Resolutions Committee shall present the resolutions to the Executive Committee for approval. Resolutions approved by the Executive Committee shall be read to the Board of Directors for informational purposes only. Copies of the approved resolutions are to be sent with the official Call to the Convention.

**Proposed Changes** In lines one and two, insert the words "at least" between "and" and "two". Then the word two in the next sentence can be deleted. In the line that begins with Eight copies, the words "Eight copies of each" should be stricken.

#### If Amended would read:

**Section 10** – The Resolutions Committee shall consist of a Chairman and at least two members. The members shall be members of the Board of Directors. The Parliamentarian or a Parliamentary Advisor shall be an advisory member of this Committee. Each resolution must be submitted to the Chairman by the date designated by the Executive Committee. The Resolutions Committee shall present the resolutions to the Executive Committee for approval. Resolutions approved by the Executive Committee shall be read to the Board of Directors for informational purposes only. Copies of the approved resolutions are to be sent with the official Call to the Convention.

**Rationale:** to conform with current practice.

**Section 18-** The GFWC-WI Leadership Committee shall be comprised of up to seven members including the chairman, the current State Director of Junior Clubs, and the most recent graduates of the GFWC LEADS Program. The chairman shall be selected from active members who have attended GFWC LEADS or have served GFWC-WI as a State President or State Director of Junior Clubs. It shall be the duty of the Leadership Committee to develop programs to promote leadership for all levels of GFWC-WI.

Proposed Change: Add the following after State Director of Junior Clubs, "Junior Leadership Chairman."

#### If Amended shall read –

**Section 18-** The GFWC-WI Leadership Committee shall be comprised of up to seven members including the chairman, the current State Director of Junior Clubs, **Junior Leadership Chairman**, and the most recent graduates of the GFWC LEADS Program. The chairman shall be selected from active members who have attended GFWC LEADS or have served GFWC-WI as a State President or State Director of Junior Clubs. It shall be the duty of the Leadership Committee to develop programs to promote leadership for all levels of GFWC-WI **Rationale:** update to current practice.

**Section 1** – Robert's Rules of Order Newly Revised, 11th edition, shall govern the GFWC-WI in all cases to which they are applicable and in which they are not inconsistent with these bylaws and any special rules of order the GFWC-WI may adopt.

**Proposed Changes:** To delete the comma and 11<sup>th</sup> following edition and the comma following edition.

#### If Amended will read:

**Section 1** – Robert's Rules of Order Newly Revised edition shall govern the GFWC-WI in all cases to which they are applicable and in which they are not inconsistent with these bylaws and any special rules of order the GFWC-WI may adopt.

**Rationale:** Robert's Rules are frequently being revised. This is in concurrence with GFWC Bylaws wording.

# **Proposed Addition to the Bylaws:**

#### New Section XXI - Ethical Standards

**Section 1**: Ethical Standards. All general members will observe high standards of ethical conduct in the execution of their duties and responsibilities as required by law and as specified in these Bylaws.

**Section 2:** Confidentiality. Officers, the Board of Directors, members or constituent divisions shall not disclose confidential or proprietary information belonging to GFWC or obtained through their affiliation with the organization, other than to persons who have a legitimate or legal need for such information.

**Section 3:** Discrimination. GFWC-WI and its members shall not discriminate against any person based on race, color, religion, national origin, disability, age or sexual orientation.

**Rationale:** GFWC-WI does not currently have bylaws to identify ethical standards for members. This bylaw is modeled after GFWC's bylaws.

**Proposed:** 2022-2024 GFWC-WI Amendments and Policy Committee.

#### Amendments to be Rescinded at the close of Convention

#### **Article X – Constituent Divisions**

**Section 3** – Cities: Clubs within a city may unite in a federation for local benefit, inter-club helpfulness and the promotion of other common interests. Active membership shall be of clubs federated fully with GFWC-WI and GFWC.

**Rationale:** This classification is no longer part of current practice.

#### **Article XVI – Committees**

**Section 15-** Junior Representation on the Board of Directors – Each program shall have at least one Junior member serving as a program chairmen. Juniors shall also be considered for Class B Standing Committees. If Junior members are not able to fill the appointed positions by April 1 of the election year, the President may fill the positions from the general membership.

**Rationale:** Upon the acceptance of the Article XVI – Committees Section 2 amendment, this section is redundant.
